## **General Conditions**

- C (e) radio equipment incorporates safeguards to ensure that the personal data and privacy of the user and of the subscriber are protected;
- NA (f) radio equipment supports certain features ensuring protection from fraud;
- NP (g) radio equipment supports certain features ensuring access to emergency services;
- NP (h) radio equipment supports certain features in order to facilitate its use by users with a disability;
- NP (i) radio equipment supports certain features in order to ensure that software can only be loaded into the radio equipment where the compliance of the combination of the radio equipment and software has been demonstrated.

#### Article 3.4

NP (a) Radio equipment falling within the categories or classes specified in Part I of Annex Ia shall be so constructed that it complies with the specifications relating to charging capabilities set out in that Annex for the relevant category or class of radio equipment.
